Scott Woods, National Telecommunications and Information Administration

As a Team Lead and Senior Broadband Program Specialist with the National Telecommunications and Information Administration's (NTIA), Mr. Woods currently leads the Connecting Minority Communities (CMC) Pilot Program and serve as a principal liaison between the CMC and BroadbandUSA program offices and key strategic partners and external stakeholder groups, including representatives from state and local governments, telecommunications/broadband companies, for-profit and non-profit corporations, and colleges/universities. She began her career in public service in the Georgia Secretary of State's Office. After working in Washington, D.C., Simmons returned to Georgia as the Assistant Director of the Georgia Elections Division and later served as Chief of Staff in the Secretary of State's Office. Simmons is a native of Marietta and holds a bachelor's
