

LMIG Fact Sheet



In 2024, there are three opportunities for cities to apply for and receive Local Maintenance and Improvement Grant (LMIG) funding.

The annual LMIG allocation is based on the total centerline road miles for each local road system and the total population of each county or city as compared with the total statewide centerline road miles and total statewide population.

Funding Opportunities

Approximately 26% of Georgia's cities have yet to apply for current, FY 2024, LMIG approved funds. These funds must be applied for by **February 28, 2024**.

An additional proposed \$200 million in funding in the State of Georgia 2024 supplemental budget will be available beginning April 1. Cities must apply for this funding by **June 30, 2024**. *The FY 2024 supplemental funding is contingent upon final approval by the House and Senate, and Gov. Kemp's signature.*

Cities will be able to apply for FY 2025 LMIG funding beginning July 1, 2024.

This is an unprecedented opportunity for local governments to receive three allocations of LMIG funding over the next 6-9 months.

Match Requirements

The LMIG match requirement is 10% for those local governments that have implemented a regional Transportation Special Purpose Sales Tax (TSPLOST). The match is 30% for those without a regional TSPLOST. *Contingent upon approval, it is anticipated there will be no local match requirement for the 2024 supplemental LMIG funding.*

Cities can request GDOT hold the funding for up to three years. This includes the proposed \$200 million in the FY 2024 supplemental budget. If a city chooses the option to have GDOT hold its allocation, it must still fill out the LMIG request form and make that request at that time.

Cities can use "bonafide" in-kind services to meet part or all of the match requirements.

Also, if you were unable to complete all of your approved projects on the previous LMIG list due to price escalations, you may want to consider resubmitting those as you may be eligible to receive credit against your match requirement.

Don't miss these three opportunities to receive funding for your local road needs.
